TERMS AND CONDITIONS

The closing date for entries is 5pm on 29th February 2016

- 1. This competition is open to Members and Friends of the RSAYS. Friends must identify a Member who connects them to the Club.
- 2. All information detailing how to enter this competition forms part of these terms and conditions. It is a condition of entry that all rules are accepted as final and that the entrant agrees to abide by these rules. The decision of the judges is final and no correspondence will be entered into. Submission of an entry will be taken to mean acceptance of these terms and conditions.
- 3. Entry forms will be available online at www.rsays.com.au or from the RSAYS office. An electronic copy of each image must be submitted BY EMAIL to general.manager@rsays.com.au or on a USB drive to the Squadron Office 161 Oliver Rogers Road, Outer Harbor, SA 5018. Photos must also be supplied by the entrant printed at 8x10 on professional photo paper for display at least 7 days prior to the Exhibition date.
- 4. The following information must accompany each entry: the entrant's name, (for non members associated member name), phone number and email contact. The approximate date the image was taken and the category for which it is being submitted. We also encourage you to submit a short paragraph (3-4 sentences) that describes the moment that the image was taken, or your memory of the trip, race or atmosphere at the time.



IMPORTANT

Minimum Image size 2 megapixels, Maximum 16 megapixels. Formats accepted JPEG, TIFF or RAW. Images may be edited for colour, composition, contrast and saturation as long as they are still authentic and not unduly digitally manipulated. Photos must also be supplied by the entrant printed at 8x10 on professional photo paper for display at Exhibition event.

- 5. All entries must be received by the advertised closing time and date. (The closing date is **5pm**, **29th February 2016**).
- 6. All images submitted must be the work of the individual submitting them. It is the responsibility of each entrant to ensure that any images they submit have been taken with the permission of the subject and do not infringe the copyright of any third party or any laws. Entrants must warrant that the images they are submitting are their own work and that they own the copyright for them.
- 7. Copyright in all images submitted for this competition remains with the respective entrants. However, in consideration of their entering the Competition, each entrant grants RSAYS a licence to reproduce and use photographic entries in any form. RSAYS will acknowledge the name of photographer where possible. Uses include, but are not limited to: exhibitions, advertisements, brochures, publications, media broadcasts, the RSAYS website, Facebook, educational and promotional materials. Signing of the entry form constitutes agreement.
- 8. **Maximum of 3 images per person may be entered**. Late, illegible, incomplete, defaced or corrupt entries will not be accepted.
- 9. No responsibility can be accepted for lost entries and proof of transmission will not be accepted as proof of receipt. Entries must not be sent through agencies or third parties.
- 10. The winning entries will be that which is judged to be the most visually appealing, original and self-explanatory. The winners will be notified at the exhibition event held after the closing date.
- 11. Prizes will be awarded to an overall winner as well as a winner in each category. The prizes will be awarded as follows: Overall Winner, Best Action / Racing Photo, Best Lifestyle / Nature / Cruising Photo, Best Captioned or Funniest Photo. Prizes are subject to availability.
- 12. The winners may be required to take part in publicity. Winners names may be disclosed to interested persons and media.
- 13. The prizes as described are available on the date of publication. All prizes are non transferable and there are no cash alternatives.
- 14. Events may occur that render the competition itself or the awarding of the prizes impossible due to reasons beyond the control of the RSAYS and accordingly the RSAYS may at its absolute discretion vary or amend the competition and the entrant agrees that no liability shall attach to the RSAYS as a result.
