

RSAYS AFL TIPPING COMPETITION 2017

1. Information on how to enter forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.
2. Entry is open to RSAYS Members and their friends only and they must be over the age of 18 years.
3. The entry fee must be paid prior to the start of round 1 for the entry to be deemed valid. Fee can be paid at the RSAYS office or charged to a members house account.
4. To enter the tipping competition, the entrant must make a selection of the teams the entrant tips to win, each 2017 AFL regular round.
5. Participants will be allocated the away teams if they fail to submit their completed tips before the commencement of each AFL round.
6. The winners of the RSAYS AFL Tipping Competition will be based on the following. The winner of first prize will be the entrant with the highest cumulative score at the end of the competition. The second prize will be awarded to the second highest cumulative total and so forth until the monies allocated to the corresponding finishing positions is complete. In the event of a tie, if after a countback the tie cannot be broken, the combined prizes of the categories that are involved in the tie will be shared by the entrants involved in the tie. At the seasons end there will also be one (1) prize to be awarded to the lowest total scorer who remains eligible for any prizes.
7. Participants will be allocated one (1) point towards their score for each correct selection of a match. In the event of a match in a given round being drawn, cancelled, abandoned, not completed or not played for any reason and/or a result is not officially declared within three (3) days of the date the match was originally scheduled to be played, it is treated as a win for both teams competing in that match for the purposes of calculating each participants' score.
8. A participant may make or change a tip for a given match in a round at any time prior to the scheduled starting time of that match.

10. Entrants can only enter once. Incomprehensible and incomplete entries (as deemed by the RSAYS) will be deemed invalid.
11. To qualify for the competition, applicable persons must provide a valid email address. Returned prize or the inability to get in contact with the winner within 24 hours will see the prize forfeited.
12. The prizes will be as follows.

1 st	65% of the prize pool
2 nd	20% of the prize pool
3 rd	10% of the prize pool
Last	5% of the prize pool
13. There will be weekly prizes of drink vouchers and merchandise during the AFL minor round season.
14. Prizes must be taken as stated and no compensation will be payable if a winner is unable to use the prize as stated.
15. Should an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the RSAYS. A request to access or modify any information provided in an entry should be directed to the RSAYS Office.
16. The RSAYS's decision is final and will not enter into correspondence regarding the competition result.
17. The RSAYS assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.
18. The RSAYS accepts no responsibility for any lost or misdirected entries due to technical disruptions, network congestion or for any other reason. The RSAYS assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of submissions, and reserves the right to take any action that may be available.
